In accordance with the Law of 02.05.2007 relating to the disclosure of major holdings, Cofinimmo announces having received a notification of shareholding from the Group Crédit Agricole with registered offices at 75008 Paris, 48 rue de la Boétie. Following the sale of shares conferring voting rights, the Group Crédit Agricole's shareholding has dropped below the notification threshold of 5 % on 02.02.2017.

Founded in 1983, Cofinimmo is today the foremost listed Belgian real estate company specialising in rental property and an important player in the European market.

The company owns a diversified property portfolio spread over Belgium, France, the Netherlands and Germany, worth over 3.3 billion EUR, representing a total surface area of nearly 1,800,000 m². Riding on demographic trends, its main investment segments are healthcare properties (44 %), offices (39 %) and distribution networks (16 %).
