## Publication of a transparency notification (article 14, first paragraph of the Law of 2 May 2007 on disclosure of major holdings)

### Summary of the notification

On 15.06.2020, Cofinimmo has received a transparency notification dated 15.06.2020 from the group BlackRock, Inc. with registered offices at 55 East 52nd Street, New York, NY, 10055, USA. By virtue of a change in the denominator on 09.06.2020<sup>1</sup>, the group now holds 4.95% of voting securities and 0.23% of equivalent financial instruments (compared to 5.08% and 0.10%, respectively, during the previous notification dated 25.05.2020).

The group BlackRock, Inc. now holds 5,18% of the voting rights in the company, including the equivalent financial instruments.

### Content of the notification

The notification dated 15.06.2020 contains the following information:

- **Raison for the notification:** passive crossing of a threshold
